# Adventist/Eastern Orthodox Christian Family in Remote Newfoundland

Rahwa Menges, her husband Dr. Dereje Habte, and their two children, Yadon and Melkam, live in Roddickton-Bide Arm, a small community located on the eastern side of the Great Northern Peninsula of Newfoundland. By most standards, the family lives in a remote area. Roddickton-Bide Arm is located about 5 hours, by car, north and a little east of Corner Brook, and approximately 10.5 hours non-stop east then north from St. John's.

Both Rahwa and Dereje, originally from Ethiopia, moved to Canada with the hopes of establishing

themselves in North America. Dereje, an Eastern Orthodox Christian, and a licensed medical doctor/ surgeon with over 9 years of experience practicing medicine in Ethiopia, upon arrival in Canada, began the process of becoming licensed to practice medicine in Canada. Rahwa, a trained school teacher and baptized member of the Seventh-day Adventist Church, was the first of the family to arrive in Canada, thus preparing the way for Dereje to join her.

Up until early 2017, Dereje, was stationed as a physician in St. Anthony, NL on a temporary basis, but finally transferred to Roddickton-Bide Arm for a 3.5 year term. He currently serves as one of two primary physicians servicing the White Bay Central Health Centre in the community. Meanwhile, Rahwa and children lived in St. John's and attended the St. John's SDA Church regularly. Once Dereje was settled, Rahwa and children moved from St. John's to Roddickton-Bide Arm to join her husband and their father.

"The community up here is so supportive", says Rahwa. "They have really tried to make us feel welcome." Neighbours often bring food, offer assistance, and generally treat the family with real kindness. While the family enjoys the people and the community, being such a great distance away

from larger communities such as Corner Brook or St. John's has its unique challenges. Winter can be quite daunting. Sometimes the only way to get around is with a snowmobile or in a big four-wheel drive. It can take a while for the roads to get plowed. Fresh food can be challenging to obtain at times. Fresh fruits and non-root vegetables are not always readily available.

One significant challenge for Rahwa is being 5 hours away from the nearest Adventist Church family. When they first moved to Roddickton-Bide Arm, Yadon and Melkam used to ask: "Are we going to church today? Why can't we go to church today?" To meet this need, Rahwa started to hold worship services in the home with her children, but without a church family it is not always easy to do. "Sometimes it can be challenging" said Rahwa.

In spite of the challenges, the family is of a good spirit. They are happy to be together and to be in such a welcoming community. Rahwa and her husband, Dereje, would appreciate your continued prayers for them and their two children, Yadon and Melkam. Visitors, phone calls, and letters are welcome. "I really miss my church family" said Rahwa, "please send my greetings to everyone."
